

## **The Agreement for participation in the conference “Mobile Beach Conference 2018”**

The present text is a public offer by Rogovskiy V. Sole Proprietor, the organizer of the event “Mobile Beach Conference 2018” (hereinafter referred to as “the Organizer”), for concluding the agreement for providing services for the participation in the event (hereinafter “the Agreement”) with any individual or legal entity (hereinafter “the Participant”) as follows.

### **1. Subject matter**

1.1. The Organizer conducts the conference “Mobile Beach Conference” and the Participant declares the participation on the grounds of the present Agreement.

1.2 The duration of the conference: 18.05.2017 starting at 21.00 and finishing on 20.05.2017 at 19.00.

On 18.05.2017 at the pre-party the Participant is obliged to appear in formal attire.

1.3. The Conference venue is the club and beach resort Ibiza, Arcadia Beach, Odessa, Ukraine.

### **2. Obligations of the parties**

2.1 The Organizer is obliged:

2.1.1. To supply the Participant with information materials of the Conference and provide services, specified in the Conference program.

2.2. The Participant is obliged:

2.2.1. To transfer the payment for the participation in the Conference before the start of the Conference, specifically on the 18th of May, 2018.

2.3. The Participant agrees, that the information received from the Participant and/or with his/her participation during the Conference (data, photos, presentations) can be used in the promotional materials and on the Conference website.

2.4. The Participant is obliged to carry with him or her the printed version of the ticket. The first name, last name and patronymic name in the ticket must correspond to the Participant’s passport data.

2.5. The Participant is obliged to provide payment for all his or her orders at the Conference venue, except for the coffee breaks, which are included into the price of the ticket.

### **3. Payment arrangements**

3.1. Based on the Registration form, filled out by the Participant, the Organizer issues the bill.

3.1.1. The price of the Standard ticket is: 4060 UAH (four thousand sixty hryvna), equivalent to 150 USD by agreement of the parties.

It comprises:

- the Participant’s personal badge;
- the Participant’s package ;
- free entrance to all the lectures and panel discussions;
- free entrance to the pre-party on May, 18 at 21.00;
- entrance to the Conference on May 19 - May 20;
- access to all pre-planned coffee breaks during the Conference.

The price of the VIP ticket is: 6770 UAH (six thousand seven hundred seventy hryvna) , equivalent to 250 USD by agreement of the parties.

It comprises:

- the Participant’s personal badge;

- the Participant's package;
  - free entrance to all the lectures and panel discussions;
  - free entrance to the pre-party on May, 18 at 21.00 (including drinks and snacks);
  - lunch in the VIP sector;
  - access to the lounge zone;
  - entrance to the Conference on May 19 - May 20;
  - access to all pre-planned coffee breaks during the Conference.
- 3.2. All the bank charges connected to the payment transfer are attributed to the Participant.
- 3.3. The payment for the participation is made by transferring the funds to the account of the Organizer, on the condition of the 100% advance payment.
- 3.4. The payment for the tickets will not be refunded.

#### **4. Refusal to participate**

4.1. The Participant has the right to refuse to participate in the Conference, having previously informed the Organizer about this decision.

#### **5. Agreement duration**

5.1. The Agreement shall enter into force on the date it is signed by the last party and stays effective until both parties fully execute their obligations.

#### **6. Settlement of disputes**

6.1. The parties will put every effort to settle the disputes amicably.

6.2. Any dispute between the parties which cannot be settled amicably shall be brought before the Economic courts of Ukraine.

#### **7. Other conditions**

7.1. The present Agreement is an integral part of the Form for Registration for Participating in the Conference.

7.2. The parties have the right to amend and offer additions to the present Agreement. The amendments and additions enter into force only on the condition of being submitted in the written form and signed by authorized representatives of the both parties.

7.3. Scanned copies of the present Agreement and the Act of the Performed Services have the same legal effect as the originals.
